Membership Qualifications And Dues Formulation

Regular Member Definition:

Any firm, partnership or corporation headquartered in North America that manufactures masonry veneer products (see below) is eligible for Regular Membership in the Association upon terms to be fixed by the Board of Directors.

Dues Formulation (Regular Membership Only):

The regular member dues will be determined on a formula based on the reporting of the applicant's prior year sales in the masonry veneer industry to MVMA General Counsel. Only manufacturers would report prior year sales.

<u>Prior Year Reported Sales</u>	<u>Dues Ranges</u>
\$1 - \$10 million	\$ 10,000
\$10 - \$25 million.....	\$ 20,000
\$25 - 50 million.....	\$ 30,000
Over \$50.....	\$ 40,000

Associate Member Definition:

Any firm, partnership or corporation engaged in supplying components, raw materials, equipment or services for the manufacture, distribution or installation of masonry veneer products or systems, may be admitted to Associate Membership in the Association. Associate members shall have the rights, privileges and obligations of membership except the right to vote.

The associate member dues for 2006 will be determined on the reporting of one-year sales

Up to \$5 Million in Sales in the Masonry Veneer Industry:	\$2,500
Over \$5 Million in Sales in the Masonry Veneer Industry:	\$5,000

Affiliate Member Definition

Any firm, partnership or corporation which, (i) is engaged in selling masonry veneer products under its own proprietary brand and label; (ii) is not engaged in the manufacture of such products, and (iii) does not sell such products at retail to consumers may be admitted to Affiliate Membership in the Association. Entities qualified to be Affiliate Members may not join the Association as Associate Members. Affiliate Members shall have the rights, privileges and obligations of Membership except the right to vote
